As you might reasonably expect of us, we consider your privacy important. We therefore take measures to protect your privacy.

Our privacy statement describes the type of data we collect and how we use, protect and disclose that data. In addition, below you can find more information about the choices you have regarding the protection of your privacy.

Bee&Cee Foods applies a number of basic principles in this regard:

- we do not ask you for personal data, unless we actually need it.
- we do not share your personal data with others, unless you issue permission or we are legally obliged to do so, or in the context of the development and delivery of our products, or in order to protect our rights.
- we use cookies to understand your preferences and to provide you with the best possible internet experience.

The type of data we collect

### Personally Identifiable Data

Some Bee&Cee Foods visitors/customers choose to communicate with us in ways that oblige us to collect personally identifiable data. The amount and type of information we collect depends on the nature of the communication, such as marketing, recipes or questions about products.

For example, we may ask visitors, customers or interested parties to provide an email address.

# This is how we protect your personally identifiable data

We want you to experience the use of our websites reliably and feel that we are doing everything we can to protect the personal data we collect. No website can guarantee complete security. However, we have in place adequate technical and security procedures to protect the personal data that you provide us with from unauthorized destruction, accidental loss, alteration, or unauthorized disclosure or access.

#### This is how we disclose your data

Bee&Cee Foods only discloses (possibly) personally identifiable data to certain employees, clients, partners and affiliated organisations. These persons may need to be aware of this data in order to process it on behalf of Bee&Cee Foods, and they have agreed not to disclose the data to others. Some of these employees, clients or affiliated organisations may be located outside of your country. Your data may have to be used by these Bee&Cee Foods

partners in order to comply with the applicable regulations. Bee&Cee Foods never rents or sells (possibly) personally identifiable data to others. The only reason Bee&Cee Foods discloses this data - other than as stated above - is if required to do so by law or by government authority.

#### How long do we retain personal data?

Bee&Cee Foods does not store your personal data for longer than is strictly necessary to achieve the purposes for which your data is collected.

## Accessing, correcting or deleting data

You have the right to access, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Bee&Cee Foods, and you have the right to data portability.

We will respond to your request as soon as possible, but within four weeks at the very latest. Bee&Cee Foods would also like to point out that you have the option of lodging a complaint with the Dutch Data Protection Authority.

#### Cookies

By using our website, you agree to our policies and consent to our use of cookies. A cookie is a file that contains an identifier (a series of letters and numbers) that is sent by a web server to a web browser, and then stored by the browser. Each time the browser requests a page from the server, the identifier is sent back to the server. This allows the browser to be recognized and tracked by the server.

- We use both 'session cookies' and 'permanent cookies' on our website. Session cookies are removed from your computer as soon as you close your browser. Permanent cookies remain stored on your computer until they are deleted or until they reach a specified expiry date.
- We use the session cookies mainly to track you during your visit to the website, to see which articles are of interest to you, to prevent abuse and to increase the security of the website. We use the permanent cookies mainly to allow our website to recognize you whenever you visit it, and to track your preferences regarding your use of our website.

In addition, you can modify the use of cookies via your browser settings. Most browsers allow you to refuse all cookies, while others permit you to refuse third party cookies only. When using Internet Explorer (version 9) for example, you can refuse all cookies by clicking on 'Tools', 'Internet options' and 'Privacy' and using the slider to choose 'Block all cookies'. However, blocking all cookies has a negative impact on the user-friendliness of many websites, including this one.
